DESCRIPTION OF ACTIVITY—This is a 2-day joint meeting that includes CME/CE credits designed for oncology physicians, pharmacists, nurses, nurse practitioners, physician assistants, as well as other healthcare professionals involved in the management of cancer patients.

Great Strides Together is a continuing education event well established in the state of Florida.
